Sealed proposals will be received by **BEECH ISLAND RURAL COMMUNITY WATER AND SEWER DISTRICT** at 630 Beech Island Avenue, Beech Island, South Carolina 29842 until Thursday, March 19, 2026 at 11:00 AM local time at which time and place they will be publicly opened and read. No submitted bid may be withdrawn after the scheduled closing time for receipt of bids for a period of ninety (90) days.

All Bidders must have a State of South Carolina Contractors WL (Water and Sewer Lines) or WP4 or higher (Sewer Plants) or License.

Work to be done: The work to be done consists of furnishing all materials, equipment and labor for the construction of:

Church Road Well (108)

Installation of A 12-inch Municipal, deep water gravel pack well including submersible pump, controls, building, chemical system, water line, site grading, fencing, electrical, mechanical, and appurtenances. Time allotted for this work is 270 consecutive calendar days for substantial and final completion.

Proposals for the complete work in one general contract shall be made on the proposal form provided and shall contain prices in words and figures for the work bid on.

Funding for the work to be performed under this contract is via a grant from South Carolina Rural Infrastructure Authority. All RIA requirements apply.

All proposals shall be accompanied by a Bid Bond drawn in favor of **BEECH ISLAND RURAL COMMUNITY WATER AND SEWER DISTRICT**, in the amount of at least five percent (5%) of the lump sum bid for the complete work; such Bid Bond representing that the Bidder, if awarded the contract, will promptly enter into a contract and furnish Performance Bond and Payment Bond as provided by law and approved by the Attorney for **BEECH ISLAND RURAL COMMUNITY WATER AND SEWER DISTRICT**. Each bond shall be equal to one hundred percent (100%) of the contract amount. The Bid Bond shall be forfeited to **BEECH ISLAND RURAL COMMUNITY WATER AND SEWER DISTRICT** as liquidated damages if the Bidder fails to execute the contract and provide Performance and Payment Bonds within ten (10) days after being notified that he has been awarded the contract.
